Please read the following policies carefully before completing the form and bring the correct documents with you on the day. Please keep this page as a reminder and arrive 15 minutes prior to the agreed time of the Nikah ceremony.

Policies

- Both bride and groom must be of marital age, in accordance to the British Law.
- Groom must be a Muslim.
- Bride must be a Muslim or from Ahl Al-Kitab.
- Both bride and groom must be present on the day of Nikah and bring the following documents: *Passport/Driving License (proof of identity) Utility Bill (proof of address) If the bride or bridegroom have been married before, they must bring proof of divorce If either bride or groom is a revert, they must bring proof of conversion*
- Wali/Wakeel must be present at the time of ceremony and bring proof of identity. If he cannot be present, please contact the council beforehand to discuss alternatives.
- Two male Muslim witnesses must be present and should also bring a proof of identity with them.
- A fee of **£300.00** (£400 if offsite) must be paid prior to the date of the Nikah (unless otherwise agreed); the Council will issue a receipt to confirm payment.

If any of the requirements listed above are not met, The Muslim Law (Shariah) Council UK reserves the right refuse to conduct the Nikah.
